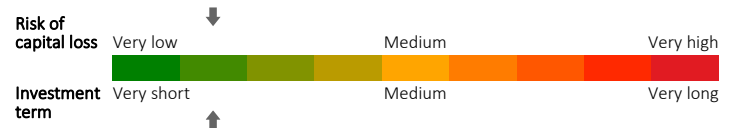

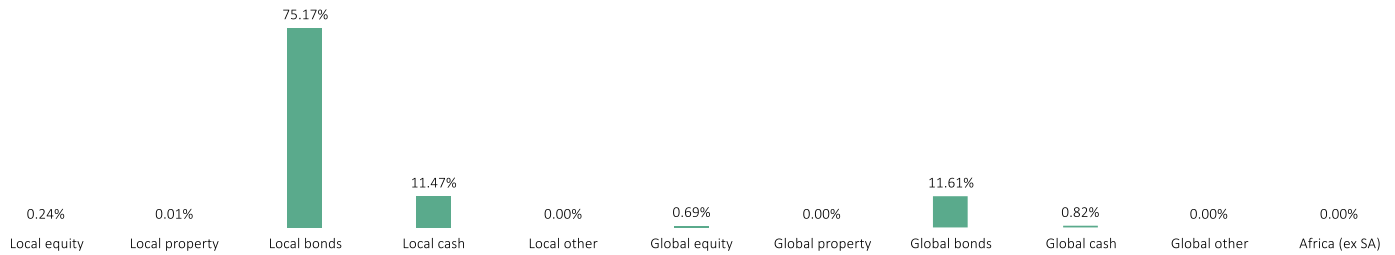

Cumulative returns



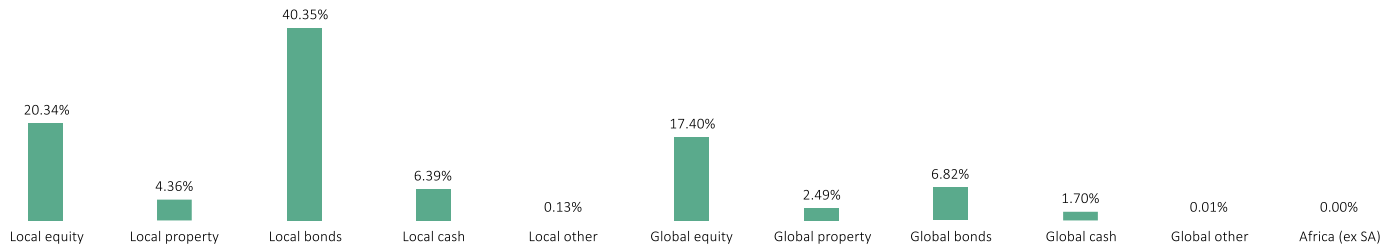

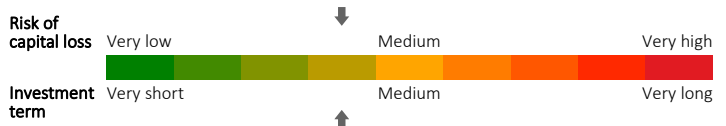

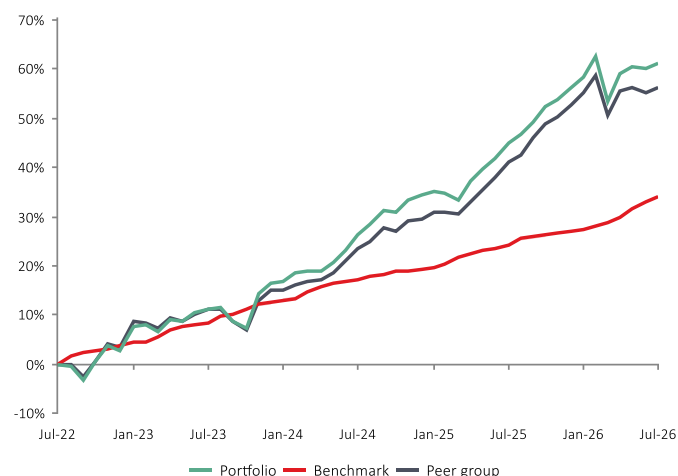

Cumulative returns



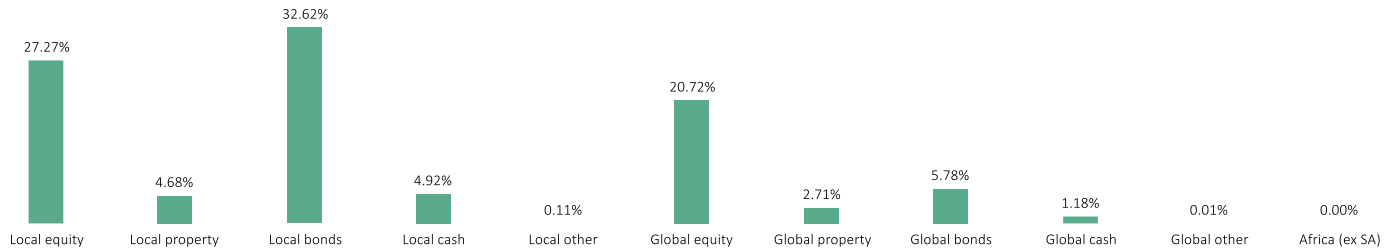

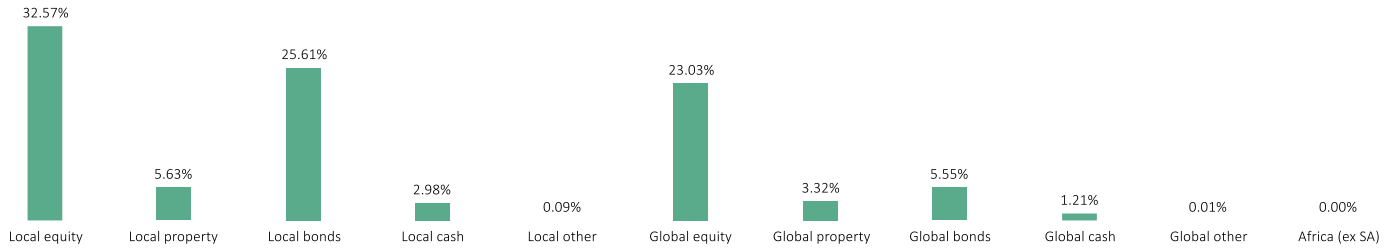

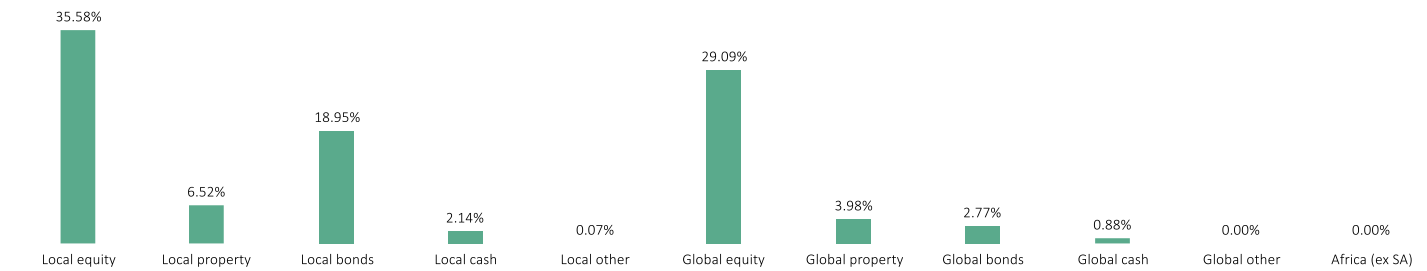

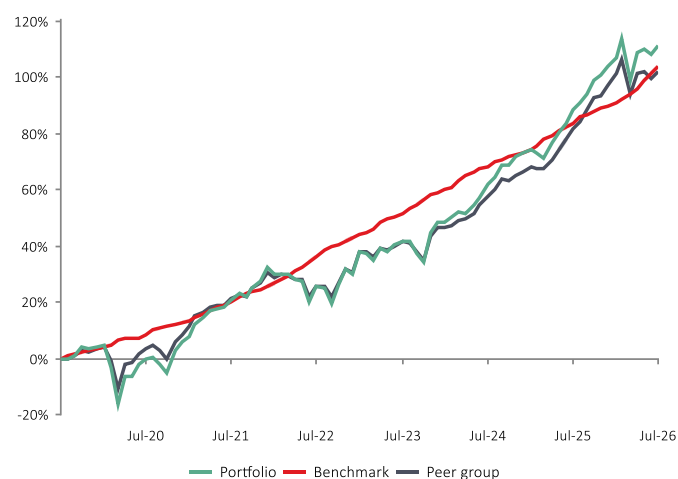

Cumulative returns



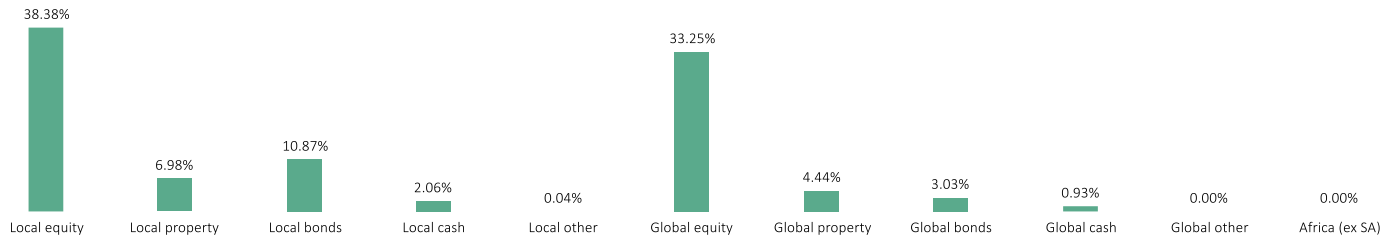

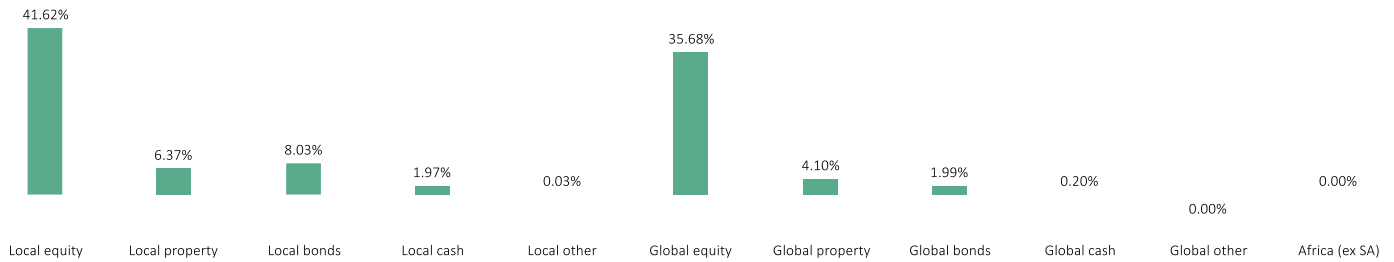

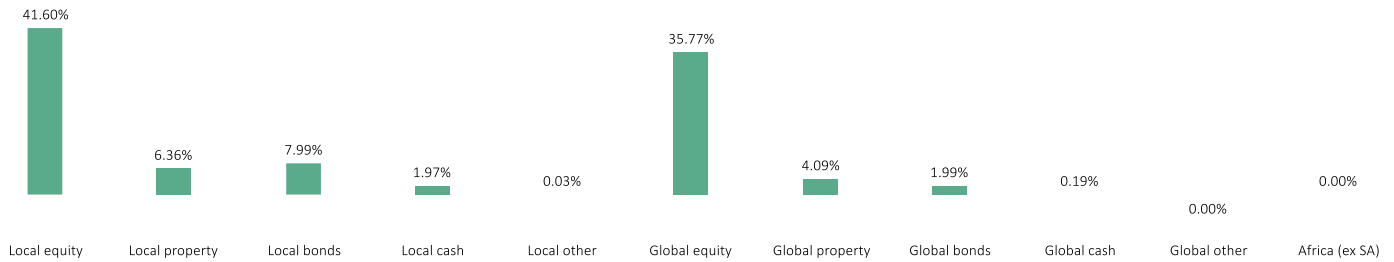

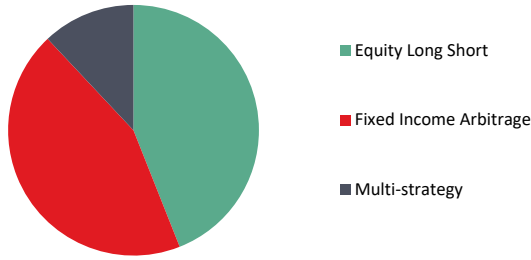

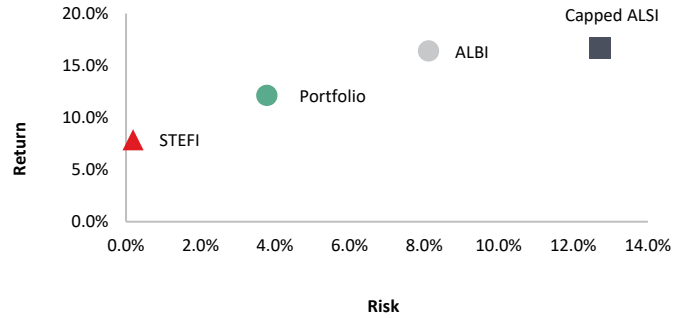

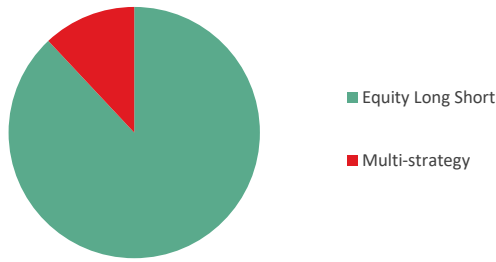

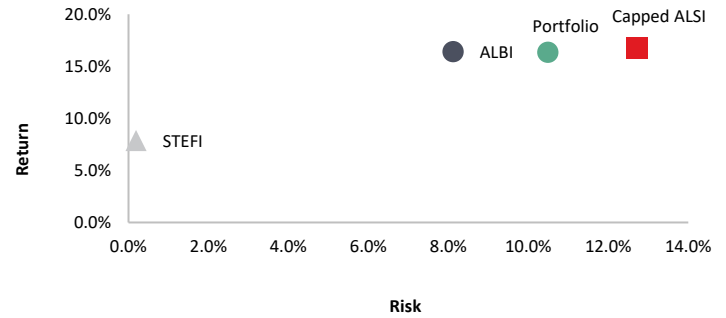

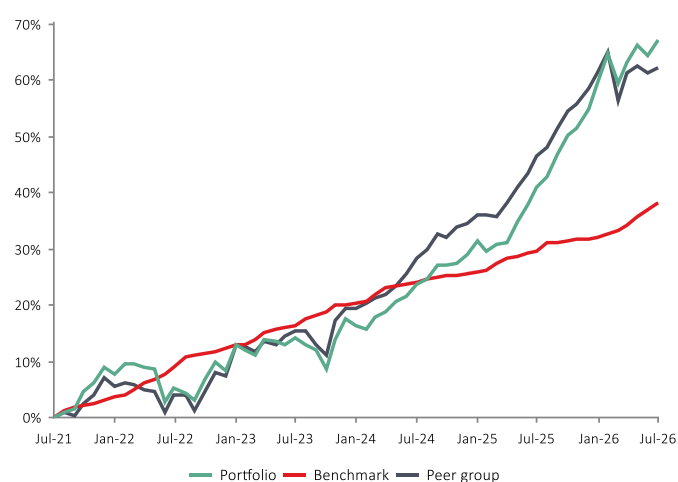

Cumulative returns



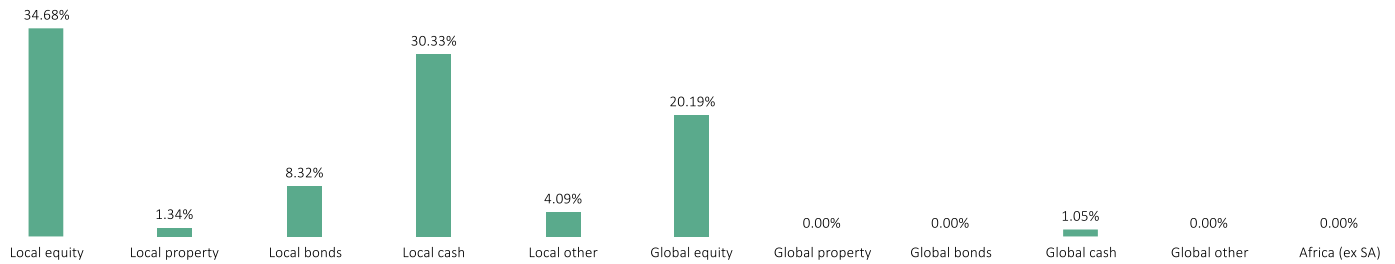

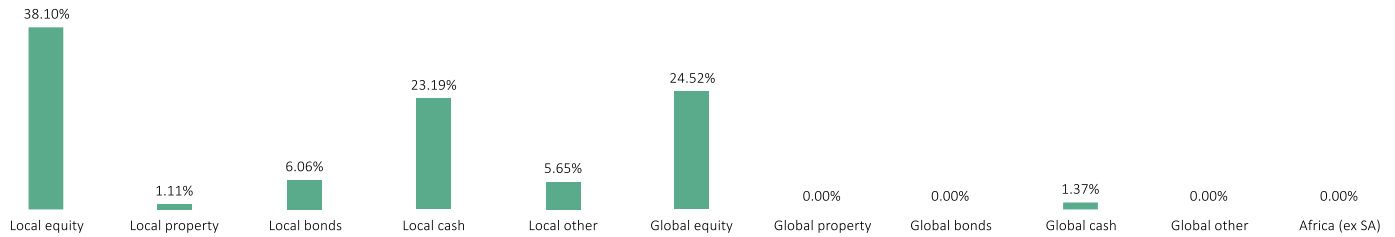
